

COOKIE POLICY - ROOM MATE

Below is the **Cookie Policy** (hereinafter "**cookie policy**" or "**policy**") that governs the Web Platform <https://room-matehotels.com/> (hereinafter, "**the Platform**"), under the ownership of **ROOM MATE HOSPITALITY LEISURE, S.L.** (hereinafter, "**ROOM MATE**" or "**we**" or "**us**"), an entity with registered office at C/ Palma, 10, (28004), Madrid - Spain.

The purpose of this **Cookie Policy** is to help you understand how we use cookies on this platform, which types we use, their purpose, and their duration, as well as the options you have to configure them, administrate them and even reject them.

1. WHAT ARE COOKIES?

Cookies are small files or devices that are downloaded and stored on your device (i.e., the device you use to access the Platform: computer, mobile phone, tablet, or any other connected device) and allow the Platform or website to remember information about your visit.

In general, and as stated in the Cookies Guide published by the Spanish Data Protection Agency (AEPD), which you can visit [here](#), several types of cookies can be found:

- **Based on the entity that manages the device or domain from which the cookies are sent and processes the obtained data, we can distinguish:**
 - **Own cookies**: These are cookies that are sent to the user's device from a device or domain managed by the editor of the platform, in this case, which provides the requested service to the user.
 - **Third-party cookies**: These are cookies that are sent to the user's device from a device or domain that is not managed by the editor of the Platform, but by another entity that processes the data obtained through the cookies. If the cookies are installed from a device or domain managed by ROOM MATE, but the information collected through these cookies is managed by a third party, they cannot be considered as ROOM MATE's own cookies. In this regard, ROOM MATE may contract the services of analytics and measurement companies that measure and/or analyze the browsing behavior of users on the platform, and in this sense, act on its behalf through the analysis of data obtained using these third-party cookies, all with the sole purpose of improving the service provided by ROOM MATE.

- **Based on the purpose for which the data obtained through cookies is processed, we can distinguish between:**
 - **Technical cookies:** These are cookies that allow the user to navigate through the platform and use the different options or services available, such as controlling traffic and data communication, identifying the session, accessing restricted access information, remembering the elements that make up a request, making a registration or participation request in an event, using security elements during navigation, storing content for video or audio broadcasting, or sharing content through social networks.
 - **Functional or personalization cookies:** These are cookies that allow the user to access the service with some pre-defined general characteristics based on a series of criteria on the user's device, such as language, the type of browser through which they access the service, or the regional configuration from which they access the service, among others.
 - **Analytics cookies:** These are cookies that allow the data controller to track and analyze the behavior of users on the connected websites. The information collected through this type of cookie is used to measure activity on the platform and create navigation profiles of users of those sites, applications, and platforms, in order to introduce improvements based on the analysis of usage data by the users of the service.
 - **Advertising cookies:** These are cookies that allow the most efficient management of the advertising spaces that the publisher has included, if applicable, on a webpage, application, or platform from which the requested service is provided, based on criteria such as edited content or the frequency of displaying ads.
 - **Behavioral advertising cookies:** These are cookies that allow the most efficient management of the advertising spaces that the publisher has included, if applicable, on a webpage, application, or platform from which the requested service is provided. These cookies store information about the behavior of users obtained through continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on that profile.
- **Based on the length of time they remain active on the user's device (temporality), we can distinguish:**
 - **Session cookies:** These are cookies designed to collect and store data while the user accesses the platform. Session cookies allow a website to recognize the user.
 - **Persistent cookies:** These are cookies in which the data remains stored on the device and can be accessed and processed for a period defined by the cookie's controller, which can range from a few minutes to several years.

2. WHAT COOKIES DOES THIS PLATFORM USE?

This Platform uses cookies to optimize and facilitate user browsing, to analyze web traffic, and to show you advertising related to your preferences based on a profile developed from your browsing habits.

Some of the cookies used are necessary to allow navigation on the platform and do not require user consent, while others do not affect the functionality of the website, and the user can accept, configure, or reject them as indicated in section "3. Management and configuration of Cookies". The cookies that are being used on this Platform and their characteristics are identified below:

It does not correspond to any user ID in the web application and does not store any personally identifiable information.
PHPSESSID	Required	Never expires	This cookie is native to PHP applications. The cookie is used to store and identify a user's unique session ID for the purpose of managing the user's session on the website. The cookie is a session cookie and is deleted when all browser windows are closed.
cookieyesID	Required	1 year	CookieYes sets this cookie as a unique identifier for visitors according to their consent.
cky-consent	Required	1 year	CookieYes sets the cookie to remember the user's consent settings so that the website recognises them the next time they visit.
cookieyes-necessary	Required	1 year	CookieYes sets this cookie to remember the consent of users for the

			use of cookies in the 'Necessary' category.
cookieyes-functional	Required	1 year	CookieYes sets this cookie to remember the user's consent for using cookies in the 'Functional' category.

_gcl_a	Analytics	3 months	This cookie is used by Google Analytics to understand user interaction with the website.

The cookie is used to calculate visitor, session, and campaign data and to track site usage for the site's analytics report. The cookies store information anonymously and assign a randomly generated number to identify individual visitors.
_gid	Analytics	1 day	This cookie is installed by Google Analytics. The cookie is used to store information of how visitors use a website and helps in creating an analytics report of how the website is doing. The data collected including the number visitors, the source where they have come from, and the pages visited in an anonymous form.
_uetclid	Analytics	1 year, 19 days, 16 hours, and 22 minutes	This cookies are used to collect analytical information about how visitors use the website. This information is used to compile report and improve site.

CLID	Analytics	1 year	Microsoft Clarity set this cookie to store information about how visitors interact with the website. The cookie helps to provide an analysis report. The data collection includes the number of visitors, where they visit the website, and the pages visited.
_clck	Analytics	1 year	Microsoft Clarity sets this cookie to retain the browser's Clarity User ID and settings exclusive to that website. This guarantees that actions taken during subsequent visits to the same website will be linked to the same user ID.

IDE	Advertising	1 year, 24 days	Used by Google DoubleClick, it stores information about how the user uses the website and any other advertisements before visiting the website. This is used to present users with ads that are relevant to them according to the user's profile.
