### 1.- INTRODUCTION

ROOM MATE, S.A. a Spanish company with registered offices at calle Velázquez 50, 3°, Madrid, Spain, and tax ID code A-82559261 (hereinafter, "We"/"Us") respects your privacy and that of the other users of this website (hereinafter, "the Website") when we collect personal data through any system permitting the transfer of data (hereinafter, "Personal Data").
